

For an otherwise solemn and serious subject, this writer makes his points clear and memorable by interspersing funny quips and reflections (which made me laugh) throughout the book. Morrison makes learning about diagnosis interesting. His sense of humor helps make this book hard to put down.

This book is very helpful. Written in plain English so you can understand diagnosis items better.

Easy to read, has lots of case studies. I found the decision trees very helpful. Be aware that (as the author himself says) he kind of straddles the *DSM IV* and *DSM 5* (which makes sense, given its publication date), so some of the terminology is technically outdated (though will likely still be used in practice for quite some time).

This book is better than his *diagnosis made easy* series. Hands down. No fluff, just what you need to know in a very concise and easy to understand manner. Buy this book!
